

**DISTRICT 9  
COMMITTEE MEETING  
JANUARY 14, 2020**

The District 9 Committee held the January 14, 2020 meeting at Aiello's Café in Ridgway, PA. The meeting was called to order by Chairman Aaron Straub. Not attending the meeting was Randy Cathcart.

A motion was made by Bill Howard and seconded by Bonnie Wolbert to approve the minutes of the November 20, 2019 meeting. The motion carried unanimously.

**FINANCE:**

A motion was made by Pete Grecco and seconded by John Sherry to approve the December 2019 and January 2020 treasurer's reports. The motion carried unanimously.

Treasurer's reports are available upon written requests.

A motion was made by Mike Erickson and seconded by Bill Jordan to accept the accounts receivable and payable report. The motion carried unanimously.

The financial reports for District 9 Competitive Spirit Championship Competition was presented.

Hometown Tickets program will not be used for the 2020 winter sports season.

**COMMUNICATIONS:**

Mr. Dan Hoffman, Principal at West Forest High School, withdrew a request for a hearing concerning granting post-season eligibility for a student athlete.

Requests were made from the Allegany Mountain Basketball League, Keystone Shortway Athletic Conference, and the North Tier League to extend the basketball season to play championship contests. A motion was made by Terry Straub and seconded by Dave Osborne to grant the request. The motion carried unanimously.

A letter was received by DuBois Area High School informing the school that Erie High School forfeited a varsity football game to DuBois Area High School for using an ineligible player.

There was an eligibility question about a Bradford Area High School athlete not residing in the Bradford Area School District. After an investigation, the student's family resides in the Bradford Area School District.

**CHAIRMAN'S UPDATE:**

Chairman Straub presented a review of the December 4, 2019 Board of Directors meeting.

The two District 9 cooperative sports agreements were passed by the Board of Directors. The PIAA Board of Directors will meet on January 22, 2020.

At the January Board of Directors meeting, the championship brackets for the next two years cycle will be presented on a first reading basis.

**ADMINISTRATIVE:**

Bill Howard updated the committee on identifying officials who have 50 years of officiating service.

The District 9 Athletic Directors Association will meet January 22, 2020 at Hoss’s in St. Marys. The Annual Athletic Directors Conference will be March 24 through 27 at the Hershey Motor Lodge.

Copies of the recommendations for officials to officiate PIAA inter-district contests will be sent to the various District 9 sports chairpersons.

The seeding committee will meet after the new championship brackets are presented.

The District 9 Website and the District 9 Handbook are being updated. The motion carried unanimously.

The committee reviewed the monthly “transfer” report from DuBois Catholic High School. A motion was made by Terry Straub and seconded by Bill Jordan to accept the report.

This sports year, District 9 has 17 disqualifications for unsportsmanlike conduct.

Consideration will be given by the Board of Directors to change the disqualification policy. Any coach or player ejected for unsportsmanlike conduct before, during, or after a contest will sit out two games and must complete the NFHS Sportsmanship Module. The school principal will report to the district sport chairman the corrective action if any further incident occurs.

The terms for female and male parents’ representatives on the District 9 Committee will expire on June 30, 2020. Any person interested in being considered for one of the positions may submit a letter of interest to Aaron Straub or Bob Tonkin by August 1, 2020. Representatives who presently serve in this position are welcome to re-apply.
